

CONTRACT AND AGREEMENT

This contract, made and, executed this 26th day of February 2021 between the Municipality of Santa Ignacia, Province of Tarlac represented by **MAYOR NORA T. MODOMO** (hereinafter called the “**ENTITY**”) and **MALTA CONSTRUCTION & SUPPLY** represented by **TOMAS P. MULDONG JR.** with office address at Barangay Anupul, Bamban, Tarlac (hereinafter called the “**CONTRACTOR**”)

WHEREAS, the **ENTITY** is desirous that the **CONTRACTOR** execute the “**FURNISHING AND DELIVERING OF LABOR, MATERIALS AND EQUIPMENT FOR THE CONCRETING OF ROADS – CLUSTER I AREA (A. Bunao Road, Sta. Ines West, B. Road #11, Sta. Ines East, C. Road #2, Padapada, D. Corpuz Road, Padapada)** and the **ENTITY** has accepted the Bid of the **CONTRACTOR** in the amount of **ONE MILLION NINE HUNDRED THIRTY EIGHT THOUSAND ONE HUNDRED NINETY NINE PESOS & 28/100** (P1,938,199.28) for the execution and completion of this contract and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this contract, words and expressions shall have the same meanings as are respectively assigned to them in the conditions of contract hereinafter referred to.
2. The following documents shall be attached , deemed to form and be read and construed as part of this contract, to wit;
 - a. Bid form, including all the documents/ statements contained in the bidders bidding envelopes, as annexes;
 - b. Eligibility requirements, documents and /or statements;
 - c. Performance security;
 - d. Notice of award contract and the Bidder’s conformed thereto;
 - e. Other contract documents that may be required by existing laws and/or the **ENTITY**.
3. In consideration of the payments to be made by the Municipality of Santa Ignacia to the **CONTRACTOR** as hereinafter mentioned, the **CONTRACTOR** hereby covenant with the Municipality of Sta. Ignacia to execute and complete the delivery of labor and materials and remedy any defects therein in conformity with the provisions of this contract in all respect.
4. The **ENTITY** hereby covenant to pay the **CONTRACTOR** in consideration of the execution and completion of the delivery of materials and the remedying of any defects therein, the contract price or such sum as may become payable under the provisions of this contract at the time and manner prescribed by this contract.
5. The duration of the project shall be 60 calendar days which shall commence on March 01, 2021.
6. After 60 days if the project is not fully accomplished, the **CONTRACTOR** shall be liable for damages incurred. The extent of liability for damages shall be determined by both parties.
7. The mode of payment shall be per accomplishment basis. This mode of payment shall be determined by both parties herein or their duly authorized representative.
