

CONTRACT AND AGREEMENT

This contract, made and, executed this 7th day of March 2022 between the Municipality of Santa Ignacia, Province of Tarlac represented by **MAYOR NORA T. MODOMO** (hereinafter called the "ENTITY") and **MITATA KANSAS CONSTRUCTION** represented by **ANFERNI KIM V. MARTINEZ** with office address at Sta. Ines East, Santa Ignacia, Tarlac (hereinafter called the "CONTRACTOR")

WHEREAS, the **ENTITY** is desirous that the **CONTRACTOR** execute the "FURNISHING AND DELIVERING OF LABOR, MATERIALS AND EQUIPMENT FOR THE CONSTRUCTION OF 1-CLASSROOM AT MACAGUING PRIMARY SCHOOL" and the **ENTITY** has accepted the Bid of the **CONTRACTOR** in the amount of **EIGHT HUNDRED FORTY ONE THOUSAND FOUR HUNDRED NINE PESOS (P841,409.00)** for the execution and completion of this contract and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this contract, words and expressions shall have the same meanings as are respectively assigned to them in the conditions of contract hereinafter referred to.
2. The following documents shall be attached , deemed to form and be read and construed as part of this contract, to wit;
 - a. Bid form, including all the documents/ statements contained in the bidders bidding envelopes, as annexes;
 - b. Eligibility requirements, documents and /or statements;
 - c. Performance security;
 - d. Notice of award contract and the Bidder's conformed thereto;
 - e. Other contract documents that may be required by existing laws and/or the ENTITY.
3. In consideration of the payments to be made by the Municipality of Santa Ignacia to the **CONTRACTOR** as hereinafter mentioned, the **CONTRACTOR** hereby covenant with the Municipality of Santa Ignacia to execute and complete the delivery of labor and materials and remedy any defects therein in conformity with the provisions of this contract in all respect.
4. The **ENTITY** hereby covenant to pay the **CONTRACTOR** in consideration of the execution and completion of the delivery of materials and the remedying of any defects therein, the contract price or such sum as may become payable under the provisions of this contract at the time and manner prescribed by this contract.
5. The duration of the project shall be 70 calendar days which shall commence within 10 days upon receipt of Notice to Proceed.
6. After 70 days if the project is not fully accomplished, the **CONTRACTOR** shall be liable for damages incurred. The extent of liability for damages shall be determined by both parties.
7. The mode of payment shall be per accomplishment basis. This mode of payment shall be determined by both parties herein or their duly authorized representative.
